A COPY OF THE TRAVEL AGENT ID NEED TO BE ATTACHED TO THE REQUEST FORM AND THE ORIGINAL ID CARD NEED TO BE PRESENTED AT THE CHECK-IN. IN CASE THE EMPLOYEE HAS NO ID CARD A WRITTEN, STAMPED STATEMENT IN ENGLISH IS REQUIRED FROM THE COMPANY CONFIRMING EMPLOYMENT (DATE OF JOINING, POSITION, ETC.)

1 COMPANION TRAVELLER PERMITTED PROVIDED THAT HE/SHE TRAVELS TOGETHER WITH THE ELIGIBLE EMPLOYEE ON EVERY SEGMENT OF THE JOURNEY. THE MAIN TRAVELLER AND THE COMPANION MUST BE BOOKED IN THE SAME PNR.
